WAIVER AND RELEASE AGREEMENT

THIS IS A RELEASE OF LIABILITY. PLEASE READ CAREFULLY BEFORE SIGNING.

In return for receiving permission from Get Outdoors Colorado, a project of the Colorado Nonprofit Development Center, ("Get Outdoors Colorado") for allowing me to participate as a volunteer at National Get Outdoors Colorado Day on Friday, June 10, 2011 and/or Saturday, June 11, 2011, I agree to assume all risks of loss and injury that may arise out of my participation and I agree to waive any and all claims against Get Outdoors Colorado and the other partner parties. I certify that I am in good mental and physical condition and I understand the inherent risks associated with acting as a volunteer. I understand that these risks may include, but are not limited to, slips and falls, physical activity and exertion, muscle and ligament strains, pulls and tears, abnormalities of blood pressure or cardiac arrest, assault and battery, cuts and punctures. I further understand that I risk aggravating any preexisting physical condition I may have in the performance of these services.

I hereby release, and agree to indemnify and hold harmless Get Outdoors Colorado, National Get Outdoors Day participants, and anyone else involved with this event and their respective agents, representatives, officers, employees, successors, assigns and insurers, hereinafter referred to collectively as "the Released Parties", from any and all liability, claims, demands or actions or causes of action whatsoever, arising out of damage, loss or injury to my person or property, whether anticipated or unanticipated, while participating in any of the activities contemplated by this agreement, whether such damage, loss, or injury results from the negligence of the Released Parties, their respective agents, officers, employees, successors, assigns and insurers or from some other cause. This release and agreement shall be binding upon me, my heirs, successors, assigns, administrators and executors.

In consideration of Get Outdoors Colorado allowing me to participate as a volunteer, I agree not to sue and forever release, waive and discharge Get Outdoors Colorado and its respective employees, agents, representatives, officers, directors, and any associated or sponsoring agencies and entities from any and all liability to me or my personal representative, assigns, heirs, children, dependents, spouse, and relatives for any and all claims, causes of action, losses, judgments, liens, costs, demands, or damages that are caused by or arise from any injury to me or my property regardless of the cause(s) of such injury.

I understand that Get Outdoors Colorado and other sponsoring organizations shall not be responsible for loss or theft of personal property, or damage to personal property caused by Get Outdoors Colorado, its employees, volunteers, or the public.

I expressly acknowledge, represent and agree that expressly identifying and explicitly naming the respective agents, representatives, officers, employees, successors, assigns and insurers of the parties released, all of whom I intend to be released by this document, is a practical impossibility for the parties. I expressly acknowledge that, for good and valuable consideration, the terms "respective agents, representatives, officers, employees, successors, assigns, and insurers", however used in this Waiver and Release Agreement, are expressly and explicitly intended to include all and each and every individual, person, firm, entity and corporation who are now, or at any time may have been included in the specifically listed categories.

I grant Get Outdoors Colorado and other project sponsors and partners permission to utilize my image in photographic recordings of the project, and I waive any right to claim compensation in exchange for participating in the event.

I understand that my participation as a volunteer in this activity is purely and solely voluntary and that I am not an employee, contractor, or representative of Get Outdoors Colorado or any affiliated organizations.

I agree to abide by the rules and regulations of Get Outdoors Colorado and its partners while participating in this project. I hereby acknowledge that I have read, understood, and voluntarily agreed to the foregoing waiver and release agreement.
